“Dog” means either sex.

Transfers

A transfer request from one Obedience class to another will be accepted prior to and after the trial closing date. Such requests should be sent through regular mail or e-mail, or presented to the Trial Secretary at least 30 minutes prior to the start of the trial, and should include the following information: Owner's name, dog's registered name, dog's registration #, jump height (if any), class moving from, class moving to.

Transfers made after the closing date will be judged at the end of the class.

ATTENTION EXHIBITORS

Females in season are NOT permitted to compete. After the close of entries, only refund requests for bitches in season can be accepted. Those requests must include a veterinarian's note and be received by the Trial Secretary NO LATER than one half hour prior to the start of the first class in the trial. A full refund will be given for qualified requests. There will be no refund for injury or illness after entries close.

Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases and have appropriate vaccinations.



NOTICE TO EXHIBITORS

ENTRY FEES: \$35.00 for 1st entry for each dog (includes AKC event and recording fees); \$30 per additional entry same dog, same trial.

OPENING DATE: Wednesday, July 15, 2026 at 12 noon.

CLOSING DATE for entries 11:59 p.m., Wednesday, September 16, 2026 at the Trial Secretary's office or when limits have been reached, after which time entries cannot be accepted, cancelled or substituted except as provided for in Chapter 14, Section 6 of the Dog Show Rules.

A WAIT LIST will be established for this trial to fill openings created by entries that are withdrawn prior to the closing day. The full entry fee will be refunded to an entrant whose entry is replaced by a wait-listed entry.

ENTRIES RECEIVED WITHOUT FEES will not be accepted.

RETURNED CHECKS do not constitute a valid entry fee. The Hosting Club Treasurer will add a \$30.00 collection fee to the amount of each returned check.

TELEGRAPH, TELEPHONE, FAXED, DIGITAL ENTRIES and UNSIGNED ENTRIES CANNOT BE ACCEPTED.

CREDIT CARD payment for entries for this trial will not be accepted.

ENTRIES NOT ON OFFICIAL AKC ENTRY FORMS and photocopies of AKC entry forms without the Agreement and Rules on the reverse side of the Official AKC Entry Form are **NOT ACCEPTABLE**.

NO ENTRY SHALL BE MADE AND NO ENTRY SHALL BE ACCEPTED WHICH SPECIFIES ANY CONDITIONS AS TO ITS ACCEPTANCE.

ENTRY FEES will not be refunded in the event that a dog is absent, disqualified, excused by a veterinarian or the judge, or barred from competition by the action of the Trial Committee. If because of riots, civil disturbance or other acts beyond the control of the management it is impossible to open or to complete the trial, no refund of entry fee(s) will be made.

EXTREME WEATHER CONDITIONS, such as, but not limited to snowstorms, hurricanes, lightening, extreme heat must be considered for the health and safety of the dogs, exhibitors and spectators. The well-being of dogs, exhibitors and spectators is of paramount importance and, in the event it is necessary to stop or cancel the trial before completion, no refund of entry fees will be made. If cancellation is decided before the event, every effort will be made to notify the exhibitors via email.

ERRORS ON ENTRY BLANKS. Owners are responsible for errors in making out entry forms, whoever may make such errors, and no entry fee will be refunded in event of such errors or cancellation of entries after the published closing date.

NO REFUND FOR DUPLICATE ENTRIES. We will make every effort to find all duplicate entries, but if a dog has been processed, no refund will be made.

JUMP HEIGHTS must be listed in accordance with AKC rules. **ENTRIES WITHOUT JUMP HEIGHTS** will be judged at the end of the class. Jump heights will be arranged in **ascending** order for both trials.

THE TRIAL WILL BE OPEN from 7:00 a.m. to 7:00 p.m.

AS SPECIFIED IN CHAPTER 12, SECTION 4 of the AKC Rules Applying to Dog Shows, information contained on the entry form is required to be published in the club's show catalog. This information is also subject to publication in other media.

DOGS MAY ARRIVE any time prior to their scheduled time of judging. **Dogs not required for further judging will be excused.**

JUDGES WILL NOT WAIT FOR ANY DOG HOLDING UP A CLASS. Owners or agents alone are responsible for the presence of their dogs in the judging ring when their classes are called to be judged.

ALL DOGS PRESENT must be held on a leash or confined to their crates except when being judged or when in the exercise area. Exercise your dog in the designated potty area only; please clean up after your dog.

UNENTERED DOGS will not be permitted in the buildings as space is limited. Thank you for respecting this.

NO EX-PENS are permitted on the premises. Please bring your own chairs. Spectators are permitted in the building.

INSTRUCTIONS

1. (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
2. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. A or B division.
3. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
4. Dogs listed in the **AKC Canine PartnersSM Program** may be eligible to enter all-breed AKC Obedience trials at the club's option. These dogs should be listed as All American Dog and must include their AKC Number on the entry form and check the AKC No. box. Sire and Dam information shall remain blank for mixed breed entrants.

AGREEMENT

I certify that I am the actual owner of the dog, or that I am the duly authorized agent of the actual owner whose name I have entered above. In consideration of the acceptance of this entry, I (we) agree to abide by the rules and regulations of The American Kennel Club in effect at the time of this event, and any additional rules and regulations appearing in the premium list of this event and entry form and any decision made in accord with them. I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. I (we) certify and represent that the dog entered is not a hazard to persons or other dogs. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.
